- V. Public participation
 - a. Newberg Pickleball Club: Peter Renwick presented request to perform maintenance on and stripe ten courts, install lights for playing at night, install a practice wall, and convert horseshoe pits into six courts, improve parking and pathways. Discussion: Board objected to playing at night. Board advised the Renwick work with staff (Creighton and Petersen) and give update at July meeting. (No motion)
 - b. John Peterson raised concern over Honorary Board Member and Newberg city councilor Mike McBride's remarks objecting to proposed proclamation of LBQT Day in a recent city council meeting, citing them as homophobic and discriminatory, and his follow up conversation with Superintendent Don Clements, citing his response as dismissive. Peterson asked the Board to seek advice from legal counsel and then take action. Bart Rierson agreed; Don Loving said he would be hesitant to do anything before speaking with legal counsel; Lisa Rogers agreed and offered an apology. Rogers told Peterson that we will speak with you again shortly. (No motion)
 - c. Carol Foley reported on a proposed survey to gauge interest in trails, in collaboration with the Board of Friends of the Yamhelas-Westsider Trail. (FYWT) voted at a special meeting on June 22nd, which CPRD attended, to select Nelson Research to conduct the survey, and agreed to give \$15,000 to the CPRD Parks Foundation to be solely dedicated to the trail survey, in the event that CPRD Board approves sponsoring the survey. Don Loving described his familiarity with Nelson and commended their choice, adding that he is in support of the trail, just not CPRD doing it. Rierson supported the survey's quest for clarification on trail support. Lisa Rogers said this was an excellent step forward. Motion to sponsor the survey: Moved Bart Rierson Second Don Loving Rierson volunteered to be the point person from CPRD. Passed unanimously
