We are allowed about \$92,400,000.00 in debt. As of 6/30/2021, we have \$23,912,998 outstanding long-term debt obligations. We refinanced the loans for the golf course, property and combined them with the loan for the pool and fitness center to save money. Currently we have two loans and one bond. Please note the general fund in previous years had transferred the money to pay for debt to the Loan Service Fund. We are now paying debt out of the SDC fund.

V. Public participation

a. Joel Dicks, high school and middle school mountain bike team assistant coach, talked about user types and potential signage for trails at Bob and Crystal Rilee Pak; Dicks urged Board to keep trails open to all types of users (mountain bikes, horses, pedestrians) and teach trail etiquette for shared use. Casey Creighton said the CHT Advisory Committee will make determinations on those matters and make recommendations to the Board. Jim McMaster had staff confirm that the intention of CPRD had been to designate different trails for different user types. Don Clements suggested having designated times for different user types. Discussion: Communicate with committee and get sample signage to it for consideration.

b. Brian Bowman updated the Board on its trail maintenance at Bob and Crystal Rilee Park (See documentation.). He recommended mixed use trails when Don Loving asked his opinion, noting that education would be important. He said he is more concerned about potential damage to the trails from various users.

VII. Old business/project updates

a. Updates on projects from Casey Creighton - See packet for report. Steve Paulson from public asked about a proposed homeless encampment near golf course and near hospital, wondered if the Board knew about it; the Board did not. Clements was familiar with a proposal for a 40-unit facility but was unsure of location; he said Friends Church had written a grant application for a facility somewhere near the hospital.

Tom Sheridan asked questions about new hires at golf course. Creighton invited him to meet the new coordinator.

- b. Pickleball Advisory Committee Julie Petersen said they are not currently meeting.
- c. Chehalem Heritage Trails Advisory Committee July meeting included Don Clements. He said the committee is discussing signage and should have examples at the next meeting.
- d. Golf Course Advisory Committee Don Loving and Kat Ricker prepared application; Ricker released and publicized it; Loving said the group did not meet this month; application deadline is Aug. 19. Steve Paulson, who is on committee, said he would like to see a community tournament or a wine or soda tasting in order to help garner support from community to build a new clubhouse.
- E. Update on potential right-of-way easement on Friends' Park Clements addressed this in his report, next.

From the July 28th CPRD Board meeting I owe you a couple mixed use trail examples and examples of signage for mixed use trails.

Here are a couple examples of trail systems open to both horses and cyclists. Larger than Rilee from an acreage standpoint but I think good analogs. Both Stub and McDonald Forest aren't too far from population centers and see lots of multimodal use. Mountain bikers, horses, trail runners, walkers, and dogs. Both parks also have a mix of trail types, dirt or gravel road, wide path, and singletrack.

Most, of both trail systems, is open to all users. The trails open to mountain bikers and hikers but closed to equestrians tend to be the narrowest, windiest, most undulating trails mountain bikers value the most. These trails also tend to have treads susceptible to damage from equestrians, the heaviest and widest trail users. Because of damage, I would like to see the single track we've build at Rilee Park open to only hikers and bikers.

Regarding etiquette. Both above trail maps include copies of the "trail courtesy triangle" or "share the trail" triangle. I did a little digging to find who "owns" this sign, but it seems to be ubiquitous. I've included below the Oregon State University College of Forestry weather closure sign (shared before), and their webpage on etiquette. I think the weather closure sign is one of the fairest to all users I've seen. They also have some good guidelines regarding dogs and leashes. E-bikes came up in the conversation – McDonald Forest does not allow e-bikes, Stub Stewart does. The State of Oregon has defined e-bikes in ORS 801.258.

CPRD Parrett Mt. property purchase complete

NEWBERG, Ore. - Bob and Crystal Rilee Park has moved closer to opening to the public.

Chehalem Park and Recreation District's purchase of Parrett Mountain Farm from the Crystal Dawn Smith Rilee Foundation was completed on Jan. 29, 2014.

This transaction is part of the Crystal Dawn Smith Rilee Foundation's larger property donation to CPRD valued at more than \$6 million.

The foundation donated over \$6 million worth of land to CPRD in exchange for a \$280,000 purchase price for the 327 acres of property on Parrett Mountain. The relatively low price was figured to cover the foundation's attorney bills and remaining debt engendered by the embezzlement case involving the foundation's former executive director Liz Rhode.

"This decision to give the land to CPRD was made by the foundation as a positive answer to the best future interests of the community, following the wishes of Crystal Rillee to benefit people and allow them to enjoy the land she'd acquired," said Mary Dugan, vice president of the foundation. "Crystal wanted people to enjoy the land and the beauty of nature there and was adamantly against any future residential or business development on the property, so she would be very pleased to have it become a park."

With this acquisition and the addition of the new Bob and Crystal Rilee Park, the number of parks in Chehalem Park and Recreation District will become 23.

"This generous donation from the foundation will become a valuable legacy for our community," said CPRD Public Information Coordinator Kat Ricker. "Not only will the equestrian community return to the trails it has previously enjoyed, but the public is sure to be impressed with the opportunities our Board and staff are already planning for this spectacular property."

Bob and Crystal Rilee Park will be a scenic nature park with trails, including equestrian trails.

These trails will be part of Chehalem Heritage Trails. The new park could be open as early as July.

Some of the property will continue to be leased for farming, and discussion is underway for a potential historical museum piece to preserve the history of Parrett Mountain and the farming heritage of the land. The property also contains potential rental facilities for special events such as weddings and business retreats.

The CPRD Board of Directors approved the lease-purchase Oct. 24, 2013.

Hello Board,

My name is Kristina Ernstrom I am on the Trails Committee. I experienced a grieves situation on Saturday 8/13 at the Chehalem Aquatic Center I believe this needs to be addressed and reviewed.

I am a mother of 5 children 9 years and under. I purchased a membership with a scholarship for 5 people as my 2 youngest kids are 3, and 1. We been attending the open swims at least twice a week for the past 3 weeks. 4 of my children are not swimming, they haven't had a lot of experience in water before this time due to Covid and other circumstances so they wear a life jackets for their safety while at the pool.

Last weekend 8/6 one of the lifeguard came up to me and told me I had to keep these 4 kids in reach, it there policy that if they have life jackets they need to be in arm reach in the kid pool that is 1 foot and some odd inches deep. I did my best at corralling my kids and keeping them close by. On Tuesday, and Thursday the life guard in question was not in attendance and no other lifeguard brought up that they had to be in arm reach.

The pool is not accommodating for my husband to join us, as the ceiling are to high for him to be in the pool area, it causes him vertigo. Even then per policy we would be out numbered as the policy says we can only have 2 kids per adults.

On Saturday 8/13 the same life guard singled me out again and told me that if my kids had lifejackets on I had to keep them in arms reach. I told him that with the lifejackets on they were safe being away from me, in fact more safe than without lifejackets. The potential of my children or even other children going into the deeper pool is easy. I have seen quiet a few 4 and under heading for the deeper water without lifejackets or parents. In fact I have had to grabbed my share of littles out of the water as they were sinking below the surface and no lifeguard were around watching them and parents to far to reach them in time.

The said lifeguard contacted his manager Wendy Roberts who was not at the facility, to complain that I wasn't in compliance to the rules. She had him come back to me and tell me that I could stay the rest of the time, but the big point was I had too many kids and could only bring 2 children at a time to swim. I have no one to watch my children, and there is no babysitters at the facility. Not would that be fair in any way. With the cost of gas we all come, my husband works out during the time we are playing in the water.

To request a scholarship I had to fill out paperwork for each kid and when I paid membership they never address that I could not bring all my kids to the pool at the same time. I paid \$160 for access until October 16th this has been very awful experience. I am concerned how we are meeting the community needs with this kind of experience. It does need to be brought up that this is a slap in the face toward community members who have more then 2

children under 8 years old. It also needs to be addressed that lifejackets policy needs to be reviewed. Example: if I didn't put a life jacket on my children. I turned my back, or was distracted, one of my kids headed for the deeper pool and drowned due to no one seeing him or her. Who would be responsible? I came prepared to protect my children so I didn't need to be a helicopter mother. With lifejackets they would be safe even if their curiosity took them into the deep pool.

During the time that the lifeguard was communicating with Wendy and even afterwards there were 3 kids with lifejackets/floatation devices no parents in arms reach. I explained it to the lifeguard since he was go singling me out he needed to alert the other parents. During the 10 minutes I was contemplating the situation 2 of the children still remained without parents in arms reach running around in lifejackets. The said lifegaurd left the kids pool to wonder over to another pool with 2 other lifegaurds. Never bothering to address any other parent about their children needing to be closely monitored. This really seems like he singled me out for whatever reason.

I know there are a few other larger size families that have littles in lifejackets that have been regularly attending the aquatics. Per the policy those family would also be unable to attend if the lifeguard took a notice in their children as he did with mine.

I did asked about swim lessons prior but was told that membership and scholarship would not cover the \$70 cost. It would have to be out of pocket. If I requested a scholarship for membership I certainly can't afford 1 week of swim lessons for 1 of 5 kids. It seems like this is poorly run facility that isn't really focused on community, especially low income families, or large families. I am very disappointed in what I witnessed and experienced at the Chehalem

Aquatic Center.

I would like accommodations, or policy to be reviewed that will meet ALL community needs.

Safety is the number one priority at our facility. This is why we have policies in place to make sure everyone, especially children, are safe in the water. Below I have copied straight from our website the two policies that deal with the situation you were addressed with by my lifeguard on duty.

Children's Aquatic Center Admission Policy: The safety of your children is important to us! For the Aquatic Wing children ages 10 years and up are permitted into the facility independent of an adult. Children ages 9 years require an adult remain in the facility while the child swims (please note there are no spectators permitted on pool deck). Children ages 8 years and younger are required to have an adult in the water within arm's reach at all times. The adult's role is to assist with child's safety and social distancing. The ratio is 1 adult for 2 children in the water who are under the age of 8.

Swim Aide Policy: The aquatic center management recognizes the fun of being able to float or swim independent of adult assistance. Swim aides such as arm floats, life jackets, swim rings, etc. are permitted in the pool at the lifeguard's discretion. Safety is our biggest concern. Children with floatation devices are required to remain in non-moving shallow water unless they are able to pass the water activity readiness test without floatation. A child who is a non-swimmer, regardless of floatation assistance, is required to have an adult in the water within arm's length at all times.

As you can see both policies are in line with what our guard addressed to you on Saturday. I empathize with the frustration of not having a second adult to help you with the 5 children in the water, but I cannot be partial to any one because it's convenient. As we tell all parents, lifejackets are NOT a substitution to parental supervision! The rule board posted on the wall in the leisure pool states this; "Safety is a team effort — lifeguards and parents share the responsibility!" We are meeting the needs of all in our community in the safest way we can. Thank you for reaching out to us.

Mr. Clements,

I have a 1st grader and a 4th grader participating in this week's soccer camp and I am extremely upset. I feel like there is no accountability to what is happening at this camp. Just today I witnessed:

- 1. Took my daughter's entire team outside of the field to use the restroom for 20 full minutes. 20 minutes! Then they came back and before they did any actual soccer they took a 5 minute water break. so for 25 minutes they stood around and did nothing. Also when they were outside the fence a random man was standing close by and just staring at the little girls.
- 2. My son's team did the same and he said only 2 of the kids actually needed to go.
- 3. The littlest soccer boys coaches disappeared randomly and three of the boys ended up chasing a dragonfly so far from their designated area that they were on another field again no coaches still. A parent eventually had to get up and wrangle all the kids back to the field. Then they released all the little kids 5 minutes early and didn't bother to see who or where they went. I watched one little tiny boy run outside toward the parking lot looking for his mom who was still walking over since they were released early.
- 4. There was shoving and pushing on my daughters' team and the too young coaches didn't try to correct anything, when asked they said they knew and were just trying to get everyone to do the drills. acting upset because they were approached about a kid pushing my child around.

My kids loved the basketball camp and I thought the instructor was extremely attentive, watchful and he was able to direct his young helpers in a way that the kids felt safe and that they were gaining knowledge and skills. This camp is not that way. Maybe on the other end of the field with the bigger kids but not from the end with the littles, nor the 4th graders. I saw the guy running it a few times, none in the middle and then walking around the last 15 minutes.

We paid money, took time off work to be there with them and chose this over other options because the kids were excited only to feel like my kids aren't even safe at the camp. It's not cool. Please address these issues with the guy running it and his coaches.




